1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

3. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

4. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

- 2. Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proce edings should not be bankrupt. Bidder to upload undertaking to this effect with bid.
- 3. For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:
- a. Purchase Order copy along with Invoice(s) with self-certification by the bidder that work against the invoices have been executed.
- b. Execution certificate by client with order value.
- c. Any other document in support of order execution like Third Party Inspection release note, etc.
- 4. The contract period maybe extended for a period of 1 year after completion of initial contract period on mutual agreement not exceeding an incremental value of 6%(including GST)as per initial contract value.
- 5. The Data under this project is classified as "Sensitive" and applicable guidelines as stipulated by the Go vernment of India shall be strictly adhered by the service provider.
- 6. Service personnel of OEM/bidder will visit the installation sites for periodic preventive maintenance check up of the Servers systems two times in Twelve Months for all servers.
- 7. Apart from the periodic preventive maintenance visits, all breakdown calls on the systems cover ed und er AMC and reported to the respective OEM/bidder contact point emanating from the user will be attended to within time.
- 8. The HDD of servers would not be returned in lieu of AMC replacement due to security policy of end-user. Hence, the AMC of servers should be inclusive of DMR(defective Media Retention) support.
- 9. All servers are in working conditions and out of AMC/warranty.
- 10. The buyer has the option to add/decrease 25% UPS/server quantities of same make during the currenc y of the order.
- 11. All faults including replacement of parts shall be rectified within a maximum period of 36 hours plus no rmal transit time not exceeding 24 hours where the vendor does not have service Centre.

- 12. If the Server system is down beyond 48 hours, the penalty i.e. (i) Rs. 400 (Rs. Four Hundred per day) p er system per day for will be payable by the vendor. The penalty payment would be adjusted in final bill p ayment of the vendor.
- 13. Payment terms: Quarterly amount would be paid on production of quarterly invoice to NIC SI and satisf actory service report of NIC coordinator.
- 14. The maintenance services for servers are required for Critical Infrastructure, if the services are not atte nded in reasonable time, the buyer has the option to procure the services from alternate source at the cost of bidder.
- 15. The bidder must have the experience in maintenance of servers system in Government department du ring the last 3 years at multiple locations i.e. in minimum ten states. The copy of contract/ order must be u ploaded with the bid.
- 16. Successful bidder shall ensure that GeM Contract number is mentioned in the PBG.
- 17. Scope of Work, Eligibility Criteria, Payment Terms and List of Assets are enclosed at Buyer Uploaded AT C document and bidder shall submit the compliance on their organization letter head for the same.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
