Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
